

Policy Agreement

I do hereby entrust my pet(s) to K9 Classy Clips for the purpose of grooming my pet(s). I am aware that all due care will be taken with my pet(s) for the safety of pet and groomer. Sometimes grooming can expose or exacerbate a hidden preexisting condition. K9 Classy Clips will report any findings to owner at time of groom. K9 Classy Clips cannot diagnose a condition, but may advise you to seek veterinary attention.

If your pet has any medical problems, K9 Classy Clips asks to be made aware of them so that the groomer may take any necessary steps needed to make your pet comfortable.

In the event I need to cancel my appointment a 24 hour notice prior to my appointment will be made. Leaving a message on the K9 Classy Clips voice mail is fine.

Cancellations may occur at any time by K9 Classy Clips due to weather conditions, equipment failure, etc. Every effort will be made to contact you should this happen.

Payment: Cash, check, and credit/debit cards are accepted. Payment is due when services are rendered. There will be a \$25 non-sufficient funds/returned check fee.

K9 Classy Clips has the right to refuse service. In the event of a pet she can NOT safely handle. Grooming services can be stopped mid-groom if necessary for the safety of my pet or groomer and I understand that I will pay a minimum of a \$25 fee.

Proof of Vaccination is the owner's responsibility to provide at or before the scheduled date of grooming. Veterinary records are required and can be provided in any of the following ways.

- We can call your vet to verify only available during your vet's regular office hours.
